Five-Year Strategic Plan Rollout

Mrs. Malori Khalil & Mr. Seth Moore

- Future Facility Focus area: Historical recap; opportunities and infrastructure. Open posture to go where the Lord leads working to meet our space challenges sooner than a new facility would be possible. Partnerships and other opportunities were explored, we are working to purchase properties on the block. Nothing is under contract and properties are confidential. This meets an immediate need for additional space, and remain in close proximity to the school building. We are not looking to increase enrollment, we will continue to focus on educational quality and culture.
- Advancement Focus area: fundraising to cover the upcoming space solutions.



- Tuition model: 3 year strategic road map of tuition and salary progress. Anticipated tuition stabilization in 2026-27.
- Staffing plan: correlates with the tuition model and ESA rollout. Upcoming positions added for 2025-26. Future roles are under consideration.
- Budget Adjustments: Accruing for known repair/replacement needs; providing academic enhancements; faculty salary increase.
- Budget Recap: income, expenses, year over year, balance sheet.

- Anna Allen Future focus, any updates on the rest of the items on the Strategic Plan.
   Malori not the time to talk through it all tonight, will be released in print by the end of the school year. Jared will share more in person at next year's fireside chats.
- Anna Allen how can new families get into ACA? Mr Knoll we moved away from the
  waitlist, offering a letter of intent/application for new families. Principals are working
  through this data to fill enrollment openings. The process happened earlier this year with
  the hope to have enrollment filled by the end of the school year. Abby Bogaards Preschool/child care and Kindergarten/Begindergarten operate differently in terms of
  enrollment
- Sarah Wetzel school survey, does the association get to see those results? Mr Knoll they are used for internal purposes. Malori opportunities to do more with them.
- Tom Deierling request for a student survey. ESA question, how does the potential for a new governor and legislature impact this and what is the board planning to do about this? Jared - we are aware of the risk. Dan - data points: other states who have had this in place longer are good resources.
- Julie Galloway Can parents see the results of the CSI accreditation? Challenging the
  commendation that the board is good at communication. Parents need to be able to
  come to the board with concerns. Mr Knoll we have shared the commendations and the
  goals.
- Heidi Heisterkamp student surveys: some teachers do their own class surveys, but that is a personal thing. Agrees that this is a felt need for the faculty and students.
- Katie Robinson question about school culture: given the social climate of adolescence, what are we doing about the rise of anxiety and depression regarding digital devices?
   Wanting ACA to be proactive in this area, and helping kids through this. Mr Knoll - work has been done looking at what is in the best interest of our student body and parents.
   We have looked at local and state practices, and are in the process of creating practices for ACA.
